WITNESSETH:

That the Grantors, for Ten and no/100 (\$10.00) and other valuable considerations paid by the Grantees, the receipt of which is hereby acknowledged, has and by these presents do grant, bargain, sell and convey unto the Grantees as life tenants and in fee simple, all that certain lot or parcel of land situated in the city of Winston-Salem, Forsyth County, North Carolina and more particularly described as follow:

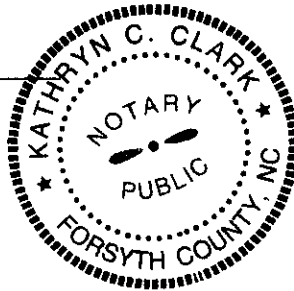

on a Map of Clinard Crest, recorded in Plat Book 10, page 92, in the office of the Register of Deeds of Forsyth County, N.C.


