WITNESSETH that said Grantor, for and in consideration of the sum of one dollar and other consideration to him in hand paid, the receipt of which is hereby acknowledged, have remised and released and by these presents do remise, release, and forever quitclaim into the Grantees and their heirs and assigns all right, title, claim, and interest of the said Grantor in and to a certain tract or parcel of land lying in Winston-Salem, Forsyth County, North Carolina, described as follows:

BEGINNING at an iron stake in the northern right-of-way line of Academy Street, said iron stake marking the southwest corner of Tax Lot 107, Block 1052 as described in Deed Book 1362, Page 469; thence from said beginning point and with the northern right-of-way line of Academy Street South 84 degrees, 00 minutes West 55.90 feet to an iron stake; thence North 02 degrees 09 minutes

West 236.94 feet to an iron stake; thence North 85 degrees 50 minutes East 55.44 feet to an iron stake in the west line of Tax Lot 107; thence with the western line of said Tax Lot 107 South 02 degrees 14 minutes East 235.15 feet to an iron stake, the point and place of BEGINNING, and being the identical property described in deed recorded in Book 1812 at Page 1817, Forsyth County Registry.
