**FORSYTH COUNTY, NORTH CAROLINA SPECIAL WARRANTY DEED**

THIS DEED made this 3rd day of September, 2008, by and between

Considerations (\$1.00 & O.V.C.) to it paid by the Grantee, the receipt of which is hereby  
acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee  
in fee simple a one-half undivided interest in that certain lot or parcel of land located in Forsyth
