FORSYTH COUNTY, NORTH CAROLINA SPECIAL WARRANTY DEED

THIS DEED made this 3rd day of September , 2008, by and between DWAYNE WASHINGTON and wife, LaVONYA N. WASHINGTON, as GRANTORS, to RONALD WILLIAMS, as GRANTEE.

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantors, in consideration of One Dollar and Other Valuable Considerations (\$1.00 & O.V.C.) to it paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple a one-half undivided interest in that certain lot or parcel of land located in Forsyth County, North Carolina, and more particularly described as follows:
