WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantees as tenants by the entirety with full rights of survivorship as at common law, and not as tenants in common, all that certain lot or parcel of land situated in the City of Kernersville, Kernersville Township, Forsyth County, North Carolina and more particularly described as follows:

BEING KNOWN AND DESIGNATED as Lot Number 7 of "WESLEY PARK", as shown on a map recorded in the Office of the Register of Deeds of Forsyth County, North Carolina, in Plat Book 40 at Page 72, reference to which is hereby made for amore particular description.

Any Lot(s) herein conveyed which is/are a part of Wesley Park shall be subject to the Plan of Development as the same is recorded in Book 1980 at Page 3339, in the Office of the Register of Deeds of Forsyth County, North Carolina.

By acceptance and recordation of this Deed, as the same relates to the Lot(s) which are herein conveyed and are a part of Wesley Park, the Grantee and each of them acknowledge that the Lot(s) above-described as a part of Wesley Park is conveyed subject to the aforesaid Plan of Development and that the Grantee and each of them shall be obligated to become and remain a member of Wesley Park Homeowner's Association so long as the Grantee and each of them shall own the above-described Lot(s) or any lot(s) in Wesley Park; that the Grantee and each of them shall be obligated to pay such dues, assessments and other sums as may be imposed from time to tome pursuant to the terms of the Plan of Development as referred to above.
