The designation Grantors and Grantees as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine feminine or neuter as required by context.

WITNESSETH, that the Grantors, in consideration of (\$1.00 & OVC) one dollars and other valuable consideration to them paid by the Grantees, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantees in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina, and more particularly described as follows:

BEGINNING at an iron stake on the west side of Thurmond Street, said stake being the southeast corner of Lot No. 9; running thence in a westerly direction along the north line of Lot No. 9 218.1 ft to an iron stake, the southwest corner of Lot No. 9; running thence in a southerly direction along the east line of Children's Home Property 50 ft to an iron stake, the northwest corner of Lot No. 7; running thence in an easternly direction along the north line of Lot No. 7 223.3 ft to an iron stake, in the west line of Thurmond Street; running thence in a northerly direction along the west line of Thurmond Street 50 ft to the place of beginning.
