This designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

**WITNESSETH**, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has remised and released and does hereby remise, release and forever quitclaim to Grantee, the Property described below: All that certain lot or parcel of land situated in the City of Winston-Salem, Forsyth County, North Carolina in Winston Township, and more particularly described as follows:

**Beginning at a point on the south side of Dixie Broadway 523.5 feet west of the southwest intersection of Dixie Broadway and Vargrave Street, and running thence in a southerly direction 133 feet to an iron stake; thence in a westwardly direction 40 feet to an iron stake; thence in a northwardly direction 132.2 feet to an iron**

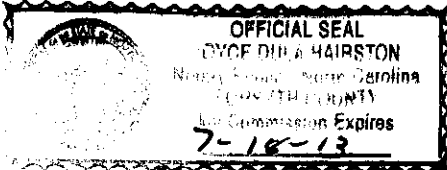
