## NORTH CAROLINA NON-WARRANTY DEED

THIS DEED made this the 3<sup>rd</sup> day of November, 2011, by and between HAROLD R. CREWS (1617 NC Hwy 66 South, Ste. 103, Kernersville, NC 27284), Grantor herein, pursuant to authority granted in an Order Permitting Foreclosure of Claim of Lien as herein after stated, to C. D. CAIN PROPERTIES, INC., (8050 West Road, Walnut Cove, NC 27052) Grantee herein. (The designation "Grantor" and "Grantee" as used herein shall include said parties, and shall include the singular, plural, masculine, feminine or neuter as required by context.)

WHEREAS: Gustavo P. Hernandez and wife, Stennett R. Hernandez were the Owner(s) of the herein described Lot 191 of the herein described Subdivision, said Lot being subject to the payment of assessments, interest, dues, etc. as stated in the Declaration of Covenants, Conditions and Restrictions (the "Declaration") recorded in Book 1741, at Page 4146, Forsyth County Registry; and,

Crews, was ordered to sell the herein described real property at public sale upon the terms and conditions as stated in the Notice of Sale, which includes the real property being sold subject to all outstanding deeds of trust, restrictions, easements, leases, liens, assessments, taxes, and any other matter of record; and,

WHEREAS, on October 17, 2011, after posting and publishing a Notice of Sale as required by the North Carolina General Statutes, Harold R. Crews at the Forsyth County Hall of Justice did offer for sale at public sale the herein described real property, where C. D. D. Cain Properties, Inc. is the final, last and highest bidder, and the remaining part of the bid has been paid to Harold R. Crews.

WITNESSETH, that Grantor, in consideration of two thousand six-hundred forty-seven dollars and fifteen cents (\$2,647.15), to Grantor paid by Grantee, the receipt and sufficiency of which are hereby acknowledged, pursuant to the Order Permitting Foreclosure of Claim of Lien as herein, stated, and pursuant to the provisions of NCGS Chapter 47F, the undersigned has and by these presents does hereby

release, grant, convey and forever quitclaim unto the Grantee, forever in fee simple, that real property located in Forsyth County, North Carolina, and being more particularly described as follows:
