Land lying in the County of Forsyth, and State of North Carolina, as follows:





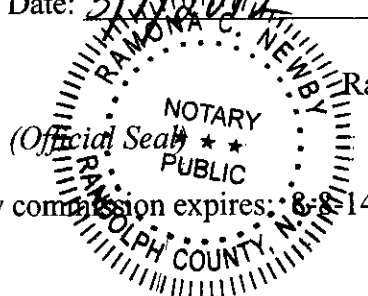
