The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in or near the City of Winston Salem, Winston Township Forsyth County, North Carolina and more particularly described as follows:

**BEGINNING at an iron stake located in the west right of way line of Sink Street, said iron stake being located South 7° 52' West 50.0 feet from the southwest intersection of the right of way lines of Sink Street and Devonshire Street, said beginning point also being located at the southeast corner of the property now or formerly owned by R. E. Swain; running thence from said beginning point with the west right of way line of Sink Street. South 7° 52' West 50 feet to an iron stake; running thence North 82° 08' West 150.55 feet to an iron stake located in the east line of a 15 foot alley; running thence with said alley, North 7° 52' East 50.0 feet to an iron stake; running thence South 82° 08' East 150.55 feet to the point and place of Beginning. Also being the same property as conveyed to Thurman Albert Marsh and Paul Edgar Marsh by deed recorded in Deed Book 1302, page 1074 in the Office of the Register of Deeds of Forsyth County, N. C. Also being designated as Lot 102, Block 751, Winston Township as shown on the Forsyth County Tax Map.**

The property hereinabove described was acquired by Grantor by instrument recorded in Book 1627, Page 5.

TO HAVE AND TO HOLD the aforesaid lot or parcel of land and all privileges and appurtenances thereto belonging to the Grantee in fee simple.

And the Grantor covenants with the Grantee, that Grantor is seized of the premises in fee simple, has the right to convey the same in fee simple, that title is marketable and free and clear of all encumbrances, and that Grantor will warrant and defend the title against the lawful claims of all persons whomsoever except for the exceptions hereinafter stated. Title to the property hereinabove described is subject to the following exceptions: those items specifically agreed to by a separate writing of the parties hereto.

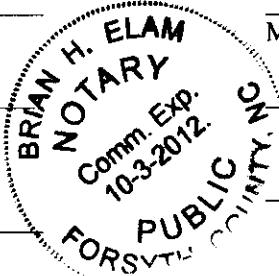
