Exhibit A (Exception Property) (Property of Charles Phillips)

Beginning at an iron pipe in the northeast margin of Willard Road, said iron pipe marking the southwest corner of the herein-described property and the southeast corner of that property conveyed to Bruce Wolfe in Book 2860, Page 2241, Forsyth County Registry, and said point also being the southeast corner of Tract 8 of the Mollie I Phillips property as shown in Plat Book17, Page 14, Forsyth County registry. Thence from said BEGINNING POINT, running with the northeast margin of Willard Road, in a southeasterly direction, 400 feet to a point; thence a new line North 02 degrees, 02' 38" East, running parallel with Wolfe's east line, 900 feet more or less to a point in the center of a creek, Wolfe's south line; thence running with the centerline of said creek as it meanders in a westerly direction, 400 feet more or less to an iron stake in Wolfe's east line; thence with Wolfe's east line South 02 degrees, 02' 38" West 20 feet to an iron pipe; thence continuing with Wolfe's east line South 02 degrees, 02' 38" West 809.99 feet to the northeast margin of Willard Road, the point and place of beginning.

The above-described property is a part of the Betty S. Phillips property as described in Deed Book 580, Page 209, Forsyth County registry, and contains approximately 7.5 acres, more or less. It is a westernmost part of PIN 6853-09-1913 as the Forsyth County tax maps are presently constituted.
