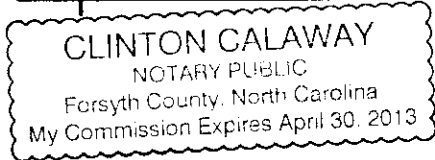

## EXHIBIT A

BEGINNING at an iron stake in the Eastern right-of-way line of Southwin Drive, said iron stake marking the Northwest corner of lot 41, in Block "B" of Westwin, Plat book 16, page 189, as recorded in the office of the Register of Deeds Forsyth County North Carolina; running thence on a curve to the right with the eastern right-of-way line of Southwin Drive, by chord measurement, North 15°05'43" West 144.62 feet to an existing iron pin; running thence North 86°06'30" East 253.05 feet to an existing iron stake in the western line of Lot 34 of the above referred Plat; running thence South 06°43'29" East 47.95 feet to a point; running thence south 36°40'47" East 15.74 feet to an iron stake, the Northeastern corner of Lot 41 of the above referred Plat; running thence with the Northern line of Lot 41, South 66°09'58" West 238.97 feet to the Point and Place of BEGINNING, containing 0.57 acres more or less. Being part of Lot 39, and all of Lot 40 in Block "B" as shown on the map of Westwin as recorded in Plat book 16 page 189 in the office of the Register of Deed of Forsyth County of North Carolina. Being in accordance with a survey for "Gerald Michael Clowney" by Clinton S. Fisher R.L.S., Dated April 12, 1993.
