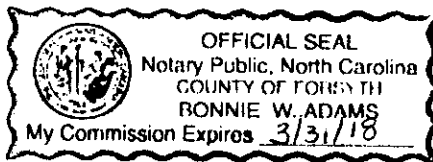


EXHIBIT A
