**WITNESSETH:**

That whereas the said MARK D. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Gary L. Warren and spouse, if any and City of Winston-Salem, Defendants, and Department of the Treasury, Internal Revenue Service, GE Capital Retail Bank, Orthopaedic Specialists of the Carolinas, P.A. and Suntrust Bank, Lienholders, et al, File No. 12-CVD-602; and said MARK D. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and


