AMENDED DECREE AND JUDGMENT OF FORFEITURE

On June 30, 2012, the Forsyth County Tax Department was served via certified mail with copies of the Verified Complaint of Forfeiture, Notice of Lis Pendens, and Legal Notice;

On July 13, 2012, Anthony Covington was served via certified mail at a second known address with copies of the Verified Complaint of Forfeiture, Notices of Lis Pendens, and Legal Notice;

On July 19, 2012, the Guilford County Tax Department was served via certified mail with copies of the Verified Complaint of Forfeiture, Notice of Lis Pendens, and Legal Notice;

- b) 1301 Bretton Street, Winston-Salem, Forsyth County, North Carolina, as more particularly described in the Forsyth County Register of Deeds Book 2989, Page 4211, with all appurtenances and improvements thereon,

shall be forfeited to the United States of America and no right, title, or interest in such

property shall exist in any other party, and the sum of Two Thousand Eight Hundred

Fifty Dollars and 00/100 (\$2,850.00) shall be forfeited to the United States of America in

lieu of the remaining defendant properties, as set forth in the Settlement Agreement with

Dejuana Covington, filed on February 12, 2014.
