This deed, made this 29th day of October, 2015, by MARK D. BARDILL, Commissioner, to Smart Business Inc as Trustee of the 1225 New Hope Lane 5M Land Trust of P.O. Box 149717, Orlando, Florida, 32814.

WITNESSETH:

That whereas the said MARK D. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Thirty Six East Limited Partnership and City of Winston-Salem, Defendants and City of Winston-Salem, Lienholder, et al, File No. 11-CVD-4658; and said MARK D. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK D. BARDILL, Commissioner, did on the 8th day of June, 2015, offer the land hereinafter described at a public sale at the Forsyth County Courthouse door, in Winston-Salem, North Carolina, and then and there the said New Hope Extension Trust became the last and highest bidder for said land for the sum of \$1.00, and that after numerous upset bids, Smart Business Inc as Trustee of the 1225 New Hope Lane 5M Land Trust became the last and highest bidder for the sum of \$168,750.00; and no upset or increased bid having been made within the time allowed by law, and said sale having been confirmed by said Court, and said MARK D. Now, therefore, for and in consideration of the premises and the sum of \$168,750.00, receipt of which is hereby acknowledged, the said MARK D. 
