BEGINNING at a point on the eastern side of Baux Mountain Road, said point of Beginning being the southwest corner of Lot No. 1 as shown on the plat hereinafter referred to, thence along the south line of Lot No. 1 in an Easterly direction 204 feet to a point in the west line of Lot No. 8; thence South 28 degrees 29 minutes West 78 feet to a point; thence North 62 degrees 05 minutes West 143.8 feet to a point; thence North 52 degrees 15 minutes East 79.6 feet to a point; thence North 54 degrees 32 minutes West 100.5 feet to a point on the eastern side of Baux Mountain Road; thence along said road in a Northeasterly course 30 feet to the place of BEGINNING. Being a part of Lot 2 and the northeastern side of Lot 3 as shown on Plat of Clifton L. Smith recorded in PB 13, PG 8 in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made.

BEGINNING at a bent existing iron pipe located in the eastern line of H & R Legacy Trust (DB 3245, PG 1218 of the Forsyth County Registry), said pipe being in the southeastern most corner of David and Evelyn Johansen (DB 3315, PG 1460 of the Forsyth County Registry) and the eastern corner of Paul R. & Rebecca J.
