This deed, made this 14th day of March, 2018, by MARK D. BARDILL, Commissioner, to SSZ, LLC of 4941 Shady Maple Ln., Winston-Salem, North Carolina, 27106.

WITNESSETH:

That whereas the said MARK D. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Shirley Mae Gordon Crisp Stewart and spouse, if any and City of Winston-Salem, et al, File No. 15-CVD-2636; and said MARK D. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK D. BARDILL, Commissioner, did on the 4th day of December, 2017, offer the land hereinafter described at a public sale at the Forsyth County Courthouse door, in Winston-Salem, North Carolina, and then and there the said Salem Acquisitions, LLC became the last and highest bidder for the sum of \$2,000.00 and that after several upset bids, SSZ, LLC became the last and highest bidder for the sum of \$14,750.00; and no upset or increased bid having been made within the time allowed by law, and said sale having been confirmed by said Court, and said MARK D. Now, therefore, for and in consideration of the premises and the sum of \$14,750.00, receipt of which is hereby acknowledged, the said MARK D. 


