THIS DEED, made this the 8th day of May, 2020, by and between **John A. Hauser, II, unmarried (a 1/2 undivided interest); Joseph F. K. Brady, Jr. (a 1/6 undivided interest) and wife, Jody C. Brady; Sarah Wooley Merritt (a 1/6 undivided interest) and husband, John Stanford Merritt; Erin Brady Rega (a 1/6 undivided interest) and husband, Vincent Anthony Rega; and, Erin Brady Rega, as Administrator of the Estate of Carol Jean Wooley** (mailing address: 536 Drumheller Road, Clemmons, NC 27012), hereinafter collectively referred to as **Grantor**; and, **Christopher B. Aiken and wife, Lisa M. Aiken** (mailing address: 319 S. Main Street, Winston-Salem, NC 27101), hereinafter referred to as **Grantee**.

WITNESSETH:

WHEREAS, John A. Hauser, II is the owner of a one-half undivided interest in the real property described below; and,

WHEREAS, Carol Jean Wooley (hereinafter referred to as the "Decedent") died intestate on October 9, 2019 seized of the remaining one-half undivided interest in the real property described below, and the Last Will and Testament of the Decedent has been duly probated and recorded in the Office of the Clerk of Superior Court of Forsyth County, North Carolina, bearing Estate File Number 19 E 2317; and,

WHEREAS, Erin Brady Rega has qualified as Administrator of the Estate of the Decedent; and,

WHEREAS, Joseph F. K. Brady, Jr., Sarah Wooley Merritt and Erin Brady Rega all of the intestate heirs of the Decedent and, as such, are the owners of Carol Jean Wooley's one-half undivided interest in the real property described below; and,

WHEREAS, notice to creditors of the estate was published as required by NCGS 28A-14-1.

NOW, THEREFORE, the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in Forsyth County, North Carolina and more particularly described as follows:

BEGINNING at an iron pipe found marking the Southeast corner of that tract of land conveyed to Mary A. Leight, as described in Deed Book 1656, Page 3289, Forsyth County Registry, and said iron pipe marking the Northeast corner of the tract herein described; thence from said Beginning point South 02° 40' 40" West 80.52 feet to an iron pipe; thence North 87° 30' 00" West 179.29 feet to an iron pipe found in the Eastern right of way of Main Street; thence following the Eastern right of way of Main Street, North 02° 10' 50" East 78.40 feet to a nail placed in the Northern right of way of Main Street; thence South 88° 10' ' 30" East 179.98 feet to the point and place of BEGINNING, containing 0.328 acres as shown on the survey dated August 2, 2001, by William Franklin Tatum, P.L.S.

And the Grantor covenants with the Grantee, that Grantor is seized of the premises in fee simple, has the right to convey the same in fee simple, that title is marketable and free and clear of all encumbrances, and that Grantor will warrant and defend the title against the lawful claims of all persons whomsoever, other than the following exceptions: **Subject to all easements, rights-of-way and restrictions of record, if any, and ad valorem taxes for the current year.**

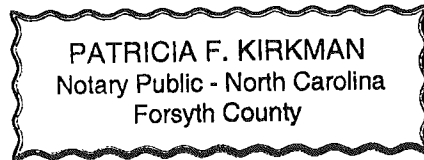

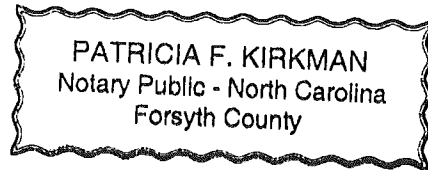
