TRUSTEE CERTIFICATION

(NCGS 36C-10-1013)

THIS CERTIFICATION (the "Certificate") made this 6 day of October, 2020, by Asa Lee Deal, Jr., TRUSTEE OF THE Asa Lee Deal, Jr. Revocable Living Trust, AS AMENDED, to Brady & Kosofsky, PA (the drafter of this Trustee Certification), Quicken Loans, Inc.
