BEGINNING at an iron on the south side of Waughtown Street, said iron being located 88.3 feet, more or less, east of the southeast intersection of Sunshine Avenue and Waughtown Street, running thence with the south margin of Waughtown Street Northeastwardly 95.7 feet to an iron; thence South  $1^{\circ} 15'$  West 167.5 feet to an iron; thence North  $89^{\circ} 45'$  West 95.7 feet to an iron; said iron being located at the northeast corner of a lot now or formerly owned by Smith also being the southeast corner of a lot now or formerly owned by Woods; thence with Woods' east line North  $1^{\circ} 15'$  East 167.5 feet to the place of BEGINNING and being the eastern portion of a lot conveyed to D.
