BEGINNING at a metal rebar found at the southwest intersection of the right-of-way of the Norfolk-Southern Railroad and Old Greensboro Road, said rebar having North Carolina Grid Coordinates (NAD 83/2011) of North(y) = 861,704.20 feet and East(x) = 1,654,965.02 feet; running thence with the southwesterly right-of-way line of Old Greensboro Road the following two (2) courses and distances: 1) South 69 deg. 36' 44" East a distance of 88.48 feet to a concrete right-of-way monument found; and 2) South 14 deg. 22' 35" East a distance of 58.32 feet to an iron pipe found in the northerly right-of-way line of Myer Lee Drive; thence with the northerly right-of-way line of Myer Lee Drive South 44 deg. 14' 03" West a distance of 412.21 feet to an iron pipe found, being the southeasterly corner of property owned, now or formerly by Myer Lee Properties, LLC (Deed Book 3039, Page 3559, and Plat Book 59, Page 115, Lot 1, Forsyth County Register of Deeds); thence with the easterly line of Myer Lee Properties, LLC North 01 deg. 18' 25" West a distance of 262.32 feet to an iron pipe found in the southerly right-of-way line of the Norfolk-Southern Railroad; thence with said rail right-of-way the following two (2) courses and distances: 1) North 60 deg. 00' 58" East a distance of 106.93 feet to an iron pipe found; and 2) North 57 deg. 05' 51" East a distance of 123.28 feet to the point and place of BEGINNING, containing 1.258 acres, more or less, BEING ALL of that same property described in Deed Book 3097, Page 2598, Forsyth County Register of Deeds.
