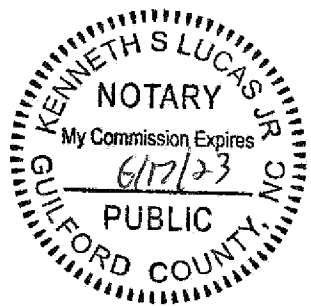


Exhibit A
