

EXHIBIT A

LEGAL DESCRIPTION (AS SURVEYED) – 900 W. MOUNTAIN STREET,
KERNERSVILLE

All that certain tract or parcel of land, being located in the Town of Kernersville, Forsyth County, North Carolina, being more particularly described as follows:

COMMENCING at an existing N.C.G.S. monument "Beam", said monument having North Carolina State Plane Grid Coordinates (NAD 83/2001) of North(y) = 867,846.47 feet and East(x) = 1,680,611.53 feet, said monument being approximately 12 feet southwesterly from the centerline of 100-foot right-of-way of the Norfolk Southern Railway and approximately 6 feet southeasterly from the northwesterly Right-of-Way line of West Bodenhamer St. [NCSR 2089] (right-of-way width varies);

THENCE from said monument S76°28'48" W, 54.43 feet to a metal rebar found at the intersection of the southwesterly right-of-way of said railway and the northwesterly right-of-way line of said street, being the true POINT AND PLACE OF BEGINNING;

THENCE along said northwesterly right-of-way line of W. Bodenhamer Street, S 70°55'39" W, 699.41 feet to a metal rebar found marking a common corner with Lapjet Enterprises LLC (Deed Book 2727, Page 802, Forsyth County Register of Deeds); said point being located N 82°38'37" E, 172.31 feet from a metal rebar found;

THENCE along the easterly line of said Lapjet Enterprises, N 02°57'29" E, 130.46 feet to a point on a timber retaining wall, said point being located S 02°57'29" W, 0.82 feet from a magnetic nail found atop said wall, said point being located S 79°35'22" E, 1.13 feet from a nail found inside of an iron pipe;

THENCE along the northerly line of said Lapjet Enterprises, N 79°35'22" W, 451.16 feet to an iron pipe found in the northeasterly right-of-way line of West Mountain Street [N.C. Highway 66] (75-foot public right-of-way as shown on Plat Book 40, Page 73);

THENCE along the northeasterly right-of-way line of W. Mountain Street the following six (6) courses and distances:

- 1) N 36°37'07" W, 59.37 feet to a metal rebar found;
- 2) N 39°18'52" W, 102.70 feet to a metal rebar found;
- 3) N 42°27'52" W, 105.68 feet to a metal rebar found;
- 4) N 44°29'23" W, 32.95 feet to a metal rebar found;
- 5) N 46°57'01" W, 138.10 feet to a metal rebar found; and
- 6) N 53°28'40" W, 123.07 feet to a magnetic nail found at the intersection of the northeasterly right-of-way line of W. Mountain Street with the southeasterly right-of-way line of Northpark Drive (60-foot private drive);

THENCE along said southeasterly right-of-way of Northpark Drive, N 22°38'45" E, 8.22 feet to a metal rebar found;

THENCE continuing along the southeasterly right-of-way of Northpark Drive,

N 22°33'40" E, 418.83 feet to a metal rebar found, said rebar marking the intersection of said southeasterly right-of-way of Northpark Drive with the southwesterly right-of-way of the Norfolk Southern Railway;

THENCE along the southwesterly right-of-way line of said railway, S 59°45'22" E, 931.14 feet to a metal rebar found;

THENCE continuing along the southwesterly right-of-way line of said railway, S 59°50'40" E, 606.57 feet to the place and POINT OF BEGINNING containing 627,917 square feet or 14.415 acres more or less.
