This deed, made this 13th day of June, 2023, by MARK B. BARDILL, Commissioner, to John Southard, Inc. of 448 Lawndale Drive, Winston-Salem, North Carolina, 27104. WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Wanda S. Brendle and spouse, if any, Defendants, and City of Winston-Salem, Defendant and Lienholder, et al, File No. 17 CvD 4381; and said MARK B. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK B.
