The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WHEREAS, the Grantor did grant, bargain, sell, and convey real property located in Forsyth County, North Carolina, unto the Grantee herein, by Quitclaim Deed dated January 29, 2021, by and between Grantor and Grantee, recorded January 29, 2021, in the Forsyth County Register of Deeds, in <u>Book 3583</u>, <u>Pages 2842</u> (the "Original Deed");

WHEREAS, the Original Deed did not indicate the marital status of the Grantor. Byron M. Ingram was married to Cheryl G. Ingram when they acquired the property on January 15, 1987 (Book 1586, Page 307). Byron M. Ingram and Cheryl G. Ingram divorced on February 14, 2011 (11 CVD 30). Byron M. Ingram married Teresa G. Ingram on June 18, 2011 (Forsyth County Book 2011, 991). Cheryl G. Ingram deeded her interest in the property to Byron M. Ingram by Quitclaim Deed recorded on June 18, 2020 (Book 3531, Page 2689). Said deed incorrectly addressed Byron M. Ingram as Byrom M. Ingram. Grantor's spouse, Teresa G. Ingram, signs this Correction Deed to release her marital interest in the property.

WHEREAS, the Original Deed did not fully describe the property. The legal description on the Original Deed did not reference the plat book and page for the lot. The legal description is hereby replaced with the attached Exhibit A.
