WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Eloy M. Pena a/k/a Eloy Maximino Pena-Mondragon and spouse, if any, and City of Winston-Salem, Defendants, and City of Winston-Salem, Wells Fargo Bank, N.A., as Trustee for the Certificateholders of Park Place Securities, Inc., Asset-Backed Pass-Through Certificates, Series 2005-WCW3, Lienholders, et al, File No. 16 CvD 7780; and said MARK B.
