WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Johnny Edward Owens and spouse, if any, and City of Winston-Salem, Defendants, and City of Winston-Salem, Bank of America, National Association, and California Lending Group, Inc. DBA United Lending Group, Lienholders, et al, File No. 17 CvD 621; and said MARK B. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK B. 
