WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Jacqueline D. Blackwell and spouse, if any, and City of Winston-Salem, Defendants and City of Winston-Salem, and JP Morgan Chase Bank, National Association, as Trustee of the Security National Mortgage Loan Trust 2001-3, Lienholders, et al, File No. 17 CvD 3647; and said MARK B. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and
