3736 Ogburn Avenue, Winston-Salem, NC 27105 Forsyth County Tax Block 0984, Lots 102, 103, and 104

BEGINNING at an old iron stake in the west line of Ogburn Avenue (formerly Creason Avenue) at the northeast corner of Lot No. 11 on the map of Bronton, Sec. No. 2 as recorded in the Forsyth County Register of Deeds in Plat Book 7 at page 110; thence with the north line of Lot No. 11 South 89 deg. 34 min. West 150.32 feet to a point, the northwest corner of Lot No. 11 and the northeast corner of Lot No. 28; thence with the north line of Lot No. 28 South 89 deg. 58 min. West 81.5 feet to an old iron stake in the east line of Hemlock Drive (formerly Carolina

Blvd.); thence with the east line of Hemlock Drive, as it curves to the left, the chord of North 06 deg. 38 min. East 60.5 feet to an iron stake at the northwest corner of Lot No. 29 and the southeast corner of Lot No. 30; thence North 85 deg. 40 min. East 73.8 feet to an iron stake that is 10 feet north of the northwest corner of Lot no. 10 and the southwest corner of Lot No. 9; thence across Lot No. 9 North 88 deg. 30 min. East 150.32 feet to an old iron stake in the west line of Ogburn Avenue, said iron stake being 10.0 feet north of the southeast corner of Lot no. 9; thence with the west line of Ogburn Avenue South 01 deg. 00 min. East 68.83 feet to the place of BEGINNING, and being lots nos. 10 and 29 and portions of lots nos. 9 and 30 on the map of Bronton Sec. 2, recorded in Plat Book 7, Page 110, also being Lot No. 29 and Parcel Nos. 102, 103, 104 and a triangle off the south side of Parcel No. 30 on map of City-County Tax Block No. 984.
