WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Dabco Holdings, Inc., Defendants, and City of Winston-Salem, Defendant and Lienholder, et al, File No. 17 CvD 3648; and said MARK B. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK B.
