This deed, made this 15th day of April, 2024, by MARK B. BARDILL, Commissioner, to Robert E. Rousseau of 219 Hemingway St., Winston-Salem, North Carolina, 27127.

WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Marcene Hairston and spouse, if any, George T. Powell, Jr. and spouse, if any, and City of Winston-Salem, Defendants, and City of Winston-Salem, W. Joseph Burns, Trustee, and Queenesther Ruth Jeffries, Lienholders, et al, File No. 19 CvD 2952; and said MARK B. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK B. BARDILL, Commissioner, did on the 8th day of February, 2024, offer the land hereinafter described at a public sale at the Forsyth County Courthouse door, in Winston-Salem, North Carolina, and then and there the said Robert E.
