WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple all that certain lot or parcel of land situated in City of Winston-Salem, Forsyth County, North Carolina and more particularly described as follows:

shown on the Map hereinafter referred to; thence from said point of Beginning and with the Southern line of Lot Number 8, North 87° 29' 05" West 247.96 feet to an iron stake within the right of way of Northampton Drive; thence North 02° 15' 00" East 93.48 feet to a point; thence North 87° 58' 15" East 248.71 feet to an iron stake in the Eastern line of Lot Number 7; thence with the East line of Lots Number 7 and 8, South 2° 16' 51" West 113.18 feet to an iron stake, the point and place of BEGINNING. Being all of Lot Number 8, and the Southern and Major portion of Lot Number 7, as shown on the Map W. W. Sell and Mrs. Emma Huff Property, recorded in Plat Book 9, page 204 of the Forsyth County Registry. For further reference see Deed Book 910, Page 182, of the Forsyth County Registry.
