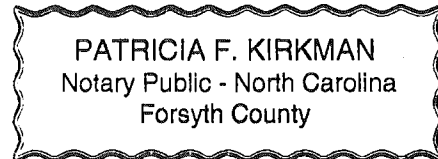

Beginning at an iron stake in the south-west corner of 2.61 acre tract conveyed to Robert L. Tuttle by Belmont G. Doub and Joy N. Doub deed recorded in Deed Book 1039, Page 1065, and running thence with the East right of way line of Kilmurry Hill Road South 17° 31' East 300.0 feet to an iron stake, a corner with Charles A. Shaw; thence North 81° 39' East 433.7 feet running with the northern boundary of Charles A. Shaw to an iron stake, a corner with Charles A. Shaw and M. Ann Needham; thence North 3° 43' East 184.1 feet running with a western boundary of M. Ann Needham to a stone known as the Mary Needham - Lanier Doub corner, said stone a corner with M.
