This deed, made this 15th day of October, 2024, by MARK B. BARDILL, Commissioner, to Darryl B. Kirsch of 3080 Mountain Brook Trl., Winston-Salem, North Carolina, 27105.

WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Roland Emory Harris and spouse, if any, et al, File No. 19 CvD 7054; and said MARK B. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK B. BARDILL, Commissioner, did on the 6th day of September, 2024, offer the land hereinafter described at a public sale at the Forsyth County Courthouse door, in Winston-Salem, North Carolina, and then and there the said Darryl B. Kirsch became the last and highest bidder for said land for the sum of \$900.00; and no upset or increased bid having been made within the time allowed by law, and said sale having been confirmed by said Court, and said MARK B. BARDILL, Commissioner, having been ordered to execute a deed to said purchaser upon payment of the purchase money;

Now, therefore, for and in consideration of the premises and the sum of \$900.00, receipt of which is hereby acknowledged, the said MARK B. BARDILL, Commissioner, does by these presents, hereby bargain, sell, grant, and convey to the said Darryl B. 
BEING a 200' x 200' tract known as Lot 17J as shown on the Forsyth County tax map, Block 5150, Salem Chapel Township.


