



CONVEYED HEREWITH is an undivided 0.0220% fee simple interest in and to the Common Elements shown on the recorded plat and all rights and easements appurtenant to said unit as specifically enumerated in the "Declaration of Condominium for One Park Vista Condominiums" (the "Declaration") and recorded in the Office of the Register of Deeds of Forsyth County in Book 2851, Page 384, as amended.

TOGETHER with all rights and easements appurtenant to the above-described unit as specifically enumerated in the Declaration, including but not limited to, membership in One Park Vista Condominium Owners Association, Inc., a North Carolina non-profit corporation (the "Association").

TOGETHER with the right of ingress and egress from and to the above-described unit over the Common Elements of One Park Vista, and the right to use the Common Elements of One Park Vista for all purposes indicated in the Declaration, in common with the Declarant therein, its successors and assigns, and in common with the other unit owners, their guests and invitees, of One Park Vista.

This conveyance is made subject to all of the terms and conditions of the Declaration, including all exhibits and attachments thereto, all of which are hereby incorporated by reference as if set forth in its entirety, and by acceptance of this deed of conveyance, the Grantee herein agrees to be bound by all of the terms and conditions of the Declaration, including but not limited to, (i) all restrictions on use of the units and Common Elements of One Park Vista, (ii) the obligation to pay Common Expenses and Special Assessments to the Association, all as defined in the Declaration, and (iii) the rights and obligations of membership in the Association.
