THIS DEED, made this the day of April, 2025, by and between Bryan C. Thompson, as Successor Trustee of the Gurprit Singh Third Party Special Needs Trust; and Bryan C. Thompson, as Successor Trustee of the Mohinder Singh Revocable Trust (a/k/a the Guru Kirpa Revocable Trust); and Bryan C. Thompson as Executor of the Estate of Mohinder Singh, hereinafter collectively referred to as Grantor; and, Austin Crocker and wife, Nichelle Crocker, (mailing address: 4702 Brighton Park Drive, Winston-Salem, NC 27103), hereinafter collectively referred to as Grantee.

WITNESSETH:

WHEREAS, Mohinder Singh, unmarried (hereinafter referred to as the "Decedent") died on August 25, 2024 seized of the real property described below in fee simple, and the Last Will and Testament of the Decedent has been duly probated and recorded in the Office of the Clerk of Superior Court of Forsyth County, North Carolina, bearing Estate File Number 25 E 265; and,

WHEREAS, Bryan C. Thompson has been duly qualified as the Executor of the Last Will and Testament of the Decedent (hereinafter referred to as the "Will"); and,

WHEREAS, Article IV of the Will bequeathed and conveyed the residuary estate of the Decedent, including real property, to the Trustee of the Mohinder Singh Revocable Trust (a/k/a the Guru Kirpa Revocable Trust), a certification of which Trust is attached as Exhibit A hereto; and,

WHEREAS, the terms of the Mohinder Singh Revocable Trust (a/k/a the Guru Kirpa Revocable Trust) provide that all of its assets, including the real property described herein, shall be distributed to the Gurprit Singh Third Party Special Needs Trust, a certification of which Special Needs Trust is attached as Exhibit B hereto; and,

WHEREAS, notice to creditors of the estate was published as required by NCGS 28A-14-1.

NOW, THEREFORE, the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in Forsyth County, North Carolina and more particularly described as follows:
