COMMISSIONER'S DEED

This deed made this <u>12</u> day of September, 2008, by John A. Meadows, Commissioner (Grantor), to County of Forsyth (Grantee).

WITNESSETH

That, whereas, John A. Meadows was appointed Commissioner under an order of the District Court of Forsyth County, North Carolina in the tax foreclosure proceeding entitled "County of Forsyth vs. Michelle Haywood, et. al. (file number 04 CVD 6964); and John A. Meadows, was directed by the order as Commissioner to sell the property hereinafter described at public sale after due advertisement according to law; and

Whereas John A.
