This deed, made this 26th day of November, 2014, by MARK D. BARDILL, Commissioner, to County of Forsyth of 201 N. Chesnut Street, Winston-Salem, North Carolina, 27101.

WITNESSETH:

That whereas the said MARK D. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Quality Investments, a N.C. General Partnership and City of Winston-Salem, Defendants, et al, File No. 12-CVD-4935; and said MARK D. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK D. BARDILL, Commissioner, did on the 5th day of May, 2014, offer the land hereinafter described at a public sale at the Forsyth County Courthouse door, in Winston-Salem, North Carolina, and then and there the said K.
