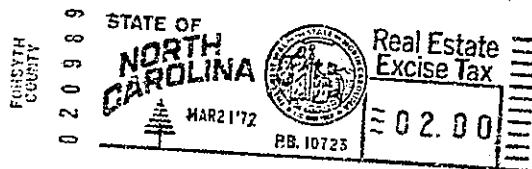
This Deed Made this 21st day of February, 1972 by and between
