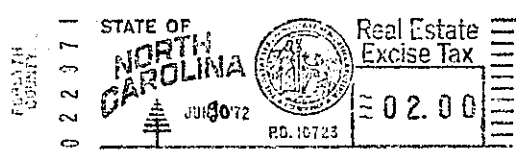
This Deed Made this 27th day of April, 19 72, by and between

Subject to restrictions and easements of record.

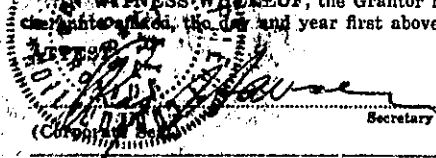
