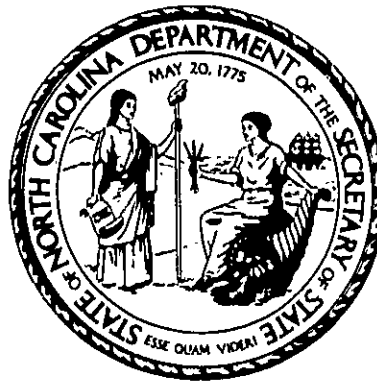

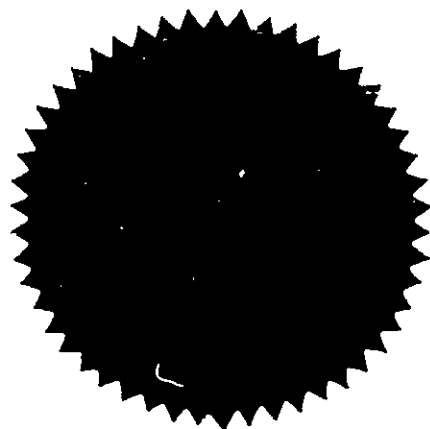

ARTICLES OF INCORPORATION

OF

S & D PLUMBING CO., INC.

The undersigned, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

1. The name of the corporation is S & D PLUMBING CO., INC.
2. The period of its duration is perpetual.
3. The purpose of the corporation is:
 - a. To engage in general plumbing, to include installing, repairing, maintaining, and otherwise working with pipes, water lines, sewer lines, and similar apparatus, and attached and related fixtures and equipment.
 - b. To engage in general construction, carpentry, and related work.
 - c. To engage in any lawful act or activity for which corporations may be organized under the North Carolina Business Corporation Act.
4. The corporation shall have the authority to issue one hundred thousand (100,000) shares, all of one class, with no par value.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is TWO THOUSAND DOLLARS (\$2,000.00).
6. The address of the initial registered office of the corporation is 2219 Granada Drive, Advance, Davie County, North Carolina, 27006. The name of the initial registered agent of the corporation at such address is Larry Wayne Dobbins.
7. The number of directors constituting the initial board of directors of the corporation is two (2). The names and addresses

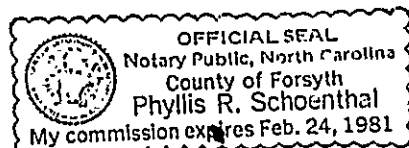
