

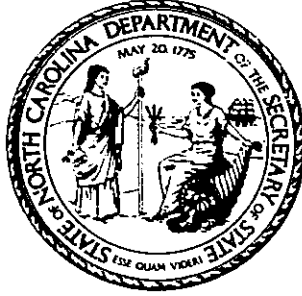

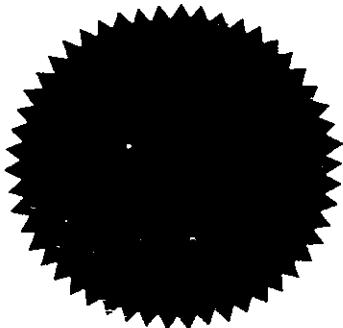

ARTICLES OF INCORPORATION  
OF  
CLEMMONS WEST HOMEOWNERS ASSOCIATION, INC.

The undersigned, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a non-profit corporation under and by the virtue of the laws of the State of North Carolina.

1. The name of the corporation is the Clemmons West Homeowners Association, Inc.

2. The period of duration of the corporation is perpetual.

3. The purposes for which the corporation is organized is for the operation of a nonpartisan, nonpolitical, nonsectarian organization to protect, sustain and maintain property values in the Clemmons West Development in Forsyth County, North Carolina, none of which are done for profit.

4. The corporation shall have members, officers and directors as shall be provided in the By-Laws. All members shall be accepted, appointed, elected or designated in the manner provided in the By-Laws.

5. The directors of the corporation shall be elected or appointed in the manner and for the terms provided in the By-Laws.

6. No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation; and upon dissolution of the corporation the assets thereof shall, after all of its liabilities and obligations have been discharged or adequate provision made therefor, be distributed to Clemmons Community Development Council, or if such organization does not exist, then to any association or associations organized for the purposes similar to those set forth in Article 3 herein above, all as more particularly provided in the By-Laws of the corporation.

7. That the initial registered office of the corporation in the State of North Carolina is 108 Spillsbury Court, Clemmons, 27012, Forsyth County, North Carolina; and the name of the initial registered agent at such address is Thomas L. Goldsmith.
