

ARTICLES OF INCORPORATION

MAL EURE SECRETARY OF STATE MYONS WEST HOMEOWNERS ASSOCIATION, INC. NORTH CAROLINA

The undersigned, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a non-profit corporation under and by the virtue of the laws of the State of North Carolina.
