

- l. The name of the corporation is $\ ^{\mbox{S \& I}}$ Construction Company, Incorporated.
 - 2. The period of duration of the corporation is perpetual.
 - 3. The purposes for which the corporation is organized are:
 - (a) to own and develop real property and to construct and erect dwelling houses and other buildings upon said real property.
 - (b) to engage in any lawful act or activity for which a corporation may be organized under Chapter 55 of the General Statutes of North Carolina.
- 4. The corporation shall have the authority to issue one hundred thousand (100,000) shares without par value.
- 5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$1.00 in cash or property of equivalent value.
