working day prior to any underground work at park site.

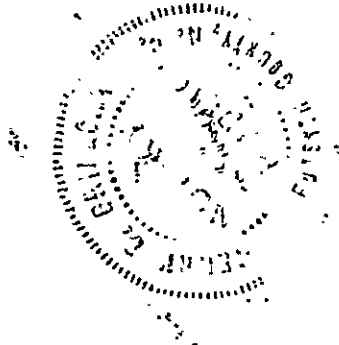

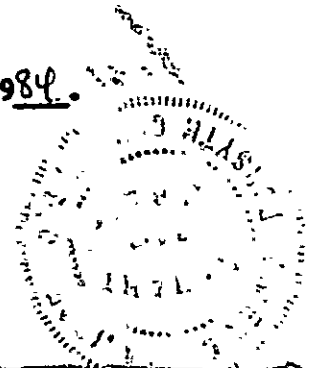
