DEED OF RELEASE

THIS RELEASE DEED, made and entered into this 5th day of June, 1991, by and between FRED E. LEWIS, III acting as Trustee, as hereinafter stated and WVTL PARTNERS, a North Carolina general partnership, of Forsyth County, North Carolina, parties of the first part and CAMBRIDGE II ASSOCIATES, a North Carolina joint venture of Forsyth County, North Carolina, hereinafter referred to as party of the second part, whether one or more persons;

W I T N E S S E T H:

That whereas, said party of the second part heretofore executed to FRED E. LEWIS, III, as Trustee, a certain deed of trust recorded in the office of the Register of Deeds of Forsyth County in Book 1629, at Page 3017, bearing date of December 11, 1987, to secure a certain note therein set out due and payable to WVTL PARTNERS; and whereas, said party of the second part has requested the said WVTL PARTNERS to release from the lien of said deed of trust so much of the land therein conveyed as is hereinafter described and the said WVTL PARTNERS has agreed so to do and has requested said Trustee to join in said release.

Said lot being a portion of old Lot 22B as shown on plat entitled "Dedication of North Point Boulevard" dated November 9, 1987, as drawn by Larry L.

TO HAVE AND TO HOLD said lands and premises, together
