SUBSTITUTION OF TRUSTEE

WHEREAS, the undersigned is the third party beneficiary of a certain deed of trust dated the 30 day of October, 1990, executed by BSH Properties, a North Carolina General Partnership to Robert C. T. Sheeran Substitute Trustee, had been originally named in said deed of trust as such Trustee.

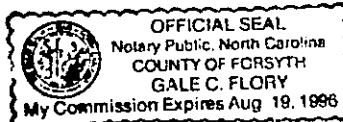
