**CORPORATION DEED**

FORSYTH COUNTY

THIS CORPORATION DEED made this 29 day of November, 1999, by and between Z & T DEVELOPMENT COMPANY, INC., a North Carolina Corporation, hereinafter referred to as "Grantor", and K. T. ISENHOUR CONSTRUCTION COMPANY, INC., hereinafter referred to as "Grantee". The designation Grantor and Grantee, as used herein, shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter, as required by context.

**WITNESSETH:**

That the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in Winston Township, Forsyth County, North Carolina and more particularly described as follows:

*BEING KNOWN AND DESIGNATED as Lot Number(s) **\*\* 6 \*\*** as shown on the plat entitled **WINSTEAD WEST** as recorded in Plat Book 39, Page 180, in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description.*

TO HAVE AND TO HOLD the aforesaid lot or parcel of land and all privileges and appurtenances thereto belonging to the Grantee in fee simple.

And the Grantor covenants with the Grantee, that Grantor is seized of the premises in fee simple, has the right to convey the same in fee simple, that title is marketable and free and clear of all encumbrances, and that Grantor will warrant and defend the title against the lawful claims of all persons whomsoever except for the exceptions hereinafter stated. Title to the property hereinabove is subject to the following exceptions: Save and except easements, rights of ways and restrictions of record and ad valorem taxes.

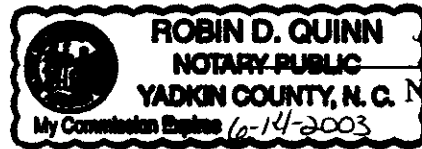
