**RELEASE DEED**

THIS RELEASE DEED, made and entered into this 10 day of March, 2006, by and between BB&T COLLATERAL SERVICE CORPORATION, Trustee (hereinafter referred to as "Trustee") and BRANCH BANKING AND TRUST COMPANY (hereinafter called "Lender") and V SALEM DEVELOPMENT CORP. (hereinafter referred to as "Borrower").

## WITNESSETH:

Phillips, as recorded in Plat Book 22, Page 115) in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description. For further reference, see Deed Book 2564, Page 3157, Forsyth County Registry.

BEING INFORMALLY KNOWN AS Tax Lot 1, Block 6581, Winston Township, Forsyth County Tax Records.

TO HAVE AND TO HOLD said lands to V SALEM DEVELOPMENT CORP, its successors and/or assigns, free and discharged from the lien of said Deed of Trust herein referred to. But it is understood and agreed that this release shall apply only to so much of said lands as are herein-described and conveyed, and that the remainder of said lands shall remain subject to the lien of said Deed of Trust and shall remain in full force and effect.
